(2) Review and Discussion of Present HSGP Situation – (Chief James Wright, State Administrative Agent) (Irene Navis, Urban Area Administrator) This item provides a review of the current circumstance of the federal government budget, DHS grant programs and associated grant announcement and guidance, as known to date. Action may be taken to formulate questions on this item from the HSWG to the Finance Committee for their guidance and input. (Discussion/Action)

(3) Presentation of FFY11 Proposed Projects – (Doug Lyon, Facilitator) This agenda item consists of brief presentations of each Proposed Project by the Project Mangers. Proposal presentations are limited to 5 minutes. Following each presentation the Working Group will be allowed time to pose questions to the Project Managers as needed. Time for the questions will be limited to no more then 5 minutes per presentation. Action may be taken to formulate questions on this item from the HSWG to the Finance Committee for their guidance and input. (Discussion/Action)

(4) Grouping of Project Proposals into Investment Justifications (IJs) – (Doug Lyon, Facilitator) This agenda item is a review of how the Proposed Projects are to be grouped into Investment Justifications for submission. The discussion will place the Proposed Projects into the appropriate IJs and assign an IJ Leader to work with the Project Managers in the development of their programs and the IJ. Actions may be taken to formulate questions on this item from the HSWG to the Finance Committee for their guidance and input and to group the proposals into their IJs. (Discussion/Action)

(5) Review and Discussion of Requested Funding – (Chief James Wright, State Administrative Agent) (Irene Navis, Urban Area Administrator) This item will be a review of the summary of initially-requested funding of Proposed Projects and a discussion of total requested funding for these projects. The Working Group may elect, after this review, to call for voluntary budget reductions/cuts in Proposed Projects from the Project Managers. Actions may be taken to reduce voluntarily reduce project budgets and to formulate questions on this item from the HSWG to the Finance Committee for their guidance and input. (Discussion/Action)

(6) Review of HSGP Process and Interim Tasking – (Mark Blomstrom, Program Manager) (Kelli Anderson, DEM) (Diana Blake, CC OEM) This item consists of a brief presentation on FFY11 HSGP process status and requirements to the Project Managers for the submission of the project plans and detailed budgets. The Working Group will assign requirements to the Program Managers to complete project plans and budgets before the next HSWG meeting on 11 April 2011 and set a time for those plans and budgets to be submitted. Actions may be taken to formulate questions on this item from the HSWG to the Finance Committee for their guidance and input and to establish a suspense date for project plans and budgets.(Discussion/Possible Action)
