- 1. CALL TO ORDER Chris Smith
- 2. ROLL CALL Hanne Epstein (DEM)
- **3. PUBLIC COMMENT** (Discussion only) No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. - **4. APPROVAL OF MINUTES** Chris Smith (Discussion/For Possible Action) This agenda item will discuss whether or not to approve the minutes of the May 11, 2011 EMCC meeting.

5. NEVADA EMERGENCY MANAGEMENT COORDINATING COUNCIL (EMCC) BYLAWS

Ms. Samantha Ladich, Senior Deputy Attorney General (Discussion/For Possible Action) This agenda item will brief the EMCC on current and/or proposed changes to the EMCC bylaws.

- 6. COMMENTS BY THE CHAIR Chris Smith (Discussion Only)
- Chris Smith will present and discuss his vision of what the EMCC should be working to achieve this year. The Chair may also discuss trends at state or national level that may affect the work of the EMCC. Some of these items may be procedural, administrative or policy trends.
- **7. EMERGENCY OPERATIONS CENTER (EOC) CONTINUITY WORKING GROUP** Ryan Turner (Discussion Only) Ryan Turner will present the work done by the EOC Continuity Working Group in Southern Nevada. The project includes looking at EOCs in Southern Nevada and standardizing them to create consistency across all jurisdictions. The presentation will explain who is participating in the project, the current status and next steps.
- **8. EMERGENCY MANAGEMENT PERFORMANCE GRANT (EMPG)** –Valerie Sumner (Discussion Only) This agenda item will present how EMPG funding will be allocated in FFY 2012, discuss documentation needed and process timelines.
- **9. THE STATE OF INTEROPERABLE COMMUNICATIONS** –Jeffrey Yeagley (Discussion only) Under this item Jeffrey Yeagley will present updates about the following areas of communications:
 - Connecting all Public Safety Answering Points (dispatch centers) in Nevada with interoperable talk groups
 - Activating 26 interoperable Radio Sites to fill communications gaps in Tribal and Rural areas
 - The two-and-a-half day Nevada Interoperability Communications Seminar: What's in it for me?
- **10. CREDENTIALING** –Kelli Baratti (Discussion Only) Kelli Baratti will provide an update on the progress of the Statewide First Responder Credentialing Project.
- 11. STATE/LOCAL INCIDENT ASSISTANCE TEAM (IMAT) Kelli Baratti (Discussion Only) Kelli Baratti will lead a discussion regarding the concept and possible implementation of state/local incident management assistance teams to support impacted jurisdictions emergency operations centers.
- **12. NEVADA EMERGENCY MANAGEMENTASSISTANCE COMPACT (NEMAC)** –Kelli Baratti (Discussion/for Possible Action) Kelli Baratti will start a discussion regarding the future and operational implementation of the NEMAC.
- **13. NEVADA DIVISION OF EMERGENCY MANAGEMENT FIELD LIAISON** –Kelli Baratti (Discussion/for Possible Action) This agenda item is to discuss the roles and responsibilities of the NDEM Field Liaison when deployed to assist a jurisdiction. The job description for this position is still being developed and NDEM would like input and direction from local emergency managers.
- 14. UPDATE ON THE FFY 2012 HOMELAND SECURITY GRANT PROGRAM (HSGP) PROCESS AND ALLOCATIONS Chris Smith (Discussion Only) Chief Smith will present the Homeland Security Grant Program status and the recommended allocations by the Nevada Homeland Security Working Group.
- **15. EMERGENCY MANAGEMENT ACCREDITATION PROGRAM (EMAP)** Bud Marshall (Discussion only) Bud Marshall will give an update on the EMAP Accreditation Process for the State of Nevada. He will brief the EMCC members on the current status of EMAP project, overview of the 6-step process, definition of the term "Emergency Management Program", and roles each of the EMCC members play as part of the Emergency Management Program.
- **16. THREAT AND HAZARD IDENTIFICATION AND RISK ASSESSMENT (THIRA)** Paul Burke (Discussion Only) The THIRA Guidance has been released from FEMA. It guides States in the development

of this critical assessment. Paul Burke will discuss how the Nevada Division of Emergency Management and Homeland Security is evaluating the guidance and developing a plan to move forward with this assessment in the coming months. Included in this process will be a component on Consequence Analysis. EMCC attendees will be provided with a copy of the THIRA guidance for their review.

17. DIRECTORS CONFERENCE / TRAINING AND EXERCISE PLANNING WORKSHOP (TEPW)

Paul Burke (Discussion/ for Possible Action) Paul Burke will present the status of preparation for the Directors' conference and TEPW in September 2012. He will then start a discussion with the members and receive suggestions on conference date and possible agenda items for the conference and the TEPW.

- **18. RECURRING AGENDA ITEMS AT EMCC MEETINGS** –Chris Smith (Discussion / for Possible Action) Chris Smith will ask the EMCC members to suggest, discuss and vote on possible recurring agenda items for the EMCC meetings.
