- 3. APPROVAL OF MINUTES** – (Discussion/For Possible Action) – Chair, Chief Caleb Cage. This agenda item will discuss whether to approve the minutes of the April 5, 2017 Emergency Preparedness Working Group meeting.
- 4. DISCUSSION OF OVERALL DEPARTMENT OF ENERGY (DOE) IMPACTS** - (Discussion Only) – Chair, Chief Caleb Cage. Members will discuss the impacts and concerns regarding the potential increase in frequency or volume of shipments into the area based on Environmental Impact Statements issued by the DOE.

8. **DISCUSSION OF CURRENT FUNDING** – (Discussion Only) – Sonja Williams. Members will discuss current funding. Discussion may include remaining funds, problems counties are facing with expending funds, and high priority items for the group overall.
