First SWIC Meeting a Success!

Representatives from 47 States and territories met on December 3-4 in Orlando, Florida for the first meeting of Statewide Interoperability Coordinators (SWICs). The meeting, hosted by the National Governors Association Center for Best Practices (NGA Center) in partnership with the Office of Emergency Communications (OEC), focused on networking, sharing best practices, and introducing resources that might assist SWICs in their interoperability efforts. Participants discussed the essential roles and responsibilities for the SWIC position, and shared best practices related to statewide governance and funding. The attendees overwhelmingly encouraged OEC to provide continued support for the group to meet in the future. The NGA Center will coordinate a second meeting in the late spring or early summer. Communications Unit Leader Training Courses Available

This year, there will be several opportunities to participate in the Office of Emergency Communication's (OEC's) All-Hazards Type III Communications Unit Leader (COML) training course (see the Calendar on Page 3 for upcoming dates). The course trains emergency responders to serve as prospective radio COMLs during all-hazards emergency operations. COML responsibilities include developing plans for the effective use of incident communications equipment and facilities, managing the distribution of communications equipment to incident personnel, and coordinating the installation and testing of communications equipment. It is designed to significantly improve communications across disciplines and jurisdictions during incident response efforts. OEC asks that Statewide Interoperability Coordinators share this opportunity with the local jurisdictions in each State and territory. - Lessons from recent activities, including NECP implementation efforts, Statewide Communication Interoperability Plan Implementation Workshops, and other communications interoperability meetings.
- Increased understanding of the next phase of NECP implementation.

Six States Chosen for Governance Policy Academy

The National Governors Association Center for Best Practices, with support from the Office of Emergency Communications and the Office for Interoperability and Compatibility, selected six States to participate in a new policy academy, Public Safety Interoperable Communications: Focus on Governance. Arizona, Arkansas, Idaho, Massachusetts, New York, and Washington will each be awarded up to \$50,000 to support a governance-specific project. Projects include developing governance body charters and by-laws; templates for multijurisdictional, multi-disciplinary agreements; performance measures to support requests for funding; and regional governance bodies. The States will also be involved in outreach efforts to underrepresented communities to strengthen diversity on their respective governance bodies. The six States convened in New Orleans, Louisiana on January 8-9, 2009 to discuss statewide governance and develop action plans for their projects.

Establishing Governance to Achieve Statewide
Communications Interoperability: A Guide for SCIP
Implementation, approved by the Department of
Homeland Security in December 2008, was developed by
OEC to help States establish multi-disciplinary and multijurisdictional coordination at all levels of government.
Without creating mandates or requirements, the guide is
designed to assist States and localities in developing and/

or refining their governance methodologies and systems, supporting States in their efforts to achieve statewide interoperability. By encouraging a coordinated, practitioner-driven approach to governance, the guide seeks to facilitate the implementation of communications interoperability strategies outlined within the National Emergency Communications Plan (NECP); each State's Statewide Communication Interoperability Plan (SCIP); and other Urban Area Security Initiative, regional, and local planning documents. The Writing Guide for a Memorandum of Understanding (MOU) tool provides guidance for developing an MOU. It includes recommendations for structuring the MOU, questions to consider when generating content for each section, and sample language to illustrate how a community could write each MOU. It can be accessed here.

The Writing Guide for Standard Operating Procedures (SOPs) guide assists communities that want to establish SOPs. SOPs are formal written guidelines or instructions for incident response. SOPs typically have both operational and technical components and enable emergency responders to act in a coordinated fashion across disciplines in the event of an emergency. The Creating a Charter for a Multi-Agency Communications Interoperability Committee

guide focuses on the governance element of the Interoperability Continuum. Specifically, it helps communities that are interested in creating a charter document for their multi-agency interoperability committee or governance group. It can be accessed here.

The Interoperable Communications for Planned Events guide is intended to assist emergency response officials who are responsible for designing and executing interoperable communication plans for planned events. IECGP Updates: Deadline Extended

The Fiscal Year 2009 Interoperable Emergency Communications Grant Program (IECGP) funding goals and priority groups were developed based on the goals, objectives, and milestones outlined in the National Emergency Communications Plan and key gaps identified through the Statewide Communication Interoperability Plan (SCIP) development process.

Statewide Interoperability Coordinators (SWICs) play a unique role in this grant program as it requires the State Administrative Agencies (SAA) to coordinate with them in proposing projects and meeting program requirements. If this contact has not already occurred, SWICs should contact the SAA to ensure that there is coordination and alignment to statewide strategies.

SAAs must complete and submit applications through www.grants.gov no later than 11:59 p.m. Eastern Standard

Time, January 23, 2009 (previously January 13, 2009). Submitted IECGP Investment Justifications will undergo a joint Office of Emergency Communications (OEC) and Federal Emergency Management Agency (FEMA) Grant Programs Directorate (GPD) review process to ensure that all Investment Justifications are compliant with program requirements before the funds are awarded in April 2009.

SCIP Implementation Workshops: Making a Difference on the Ground

The Office of Emergency Communications (OEC) is conducting Statewide Communication Interoperability Plan (SCIP) Implementation Workshops across the Nation in an effort to help States and territories implement their SCIPs and begin aligning them to the National Emergency Communications Plan. To date, 46 States and territories have signed up for workshops and OEC has completed workshops in Arkansas, Idaho, Louisiana, Massachusetts, Minnesota, Nevada, Puerto Rico, and West Virginia.

"OEC came to our State to facilitate our [SCIP Implementation] Workshop with our Statewide Interoperability Executive Committee members. The one-day workshop was an extremely valuable tool that allowed our stakeholders to prioritize the SCIP goals, develop action steps to continue forward progress, and strengthen our partnership with OEC. I want to thank OEC for the concise and organized workshop they provided to our State; it was extremely valuable and well worth the time spent. Workshops are tailored to each State's needs, enabling them to make progress on their identified priorities. Participants work hard—the workshops are designed to require active involvement from all attendees. Most importantly, the workshops provide an opportunity for stakeholders from all disciplines and levels of government to come together to advance interoperability in their State.

Examples of outcomes from the first eight workshops include action plans for the highest priority SCIP initiatives, a prioritized list of technical assistance needs, a governance charter and action plan to create a working group for sustainable communications interoperability funding, and a strategic roadmap for data interoperability initiatives. OEC anticipates that each State and territory will have unique outcomes that align to the greatest challenges facing them in their SCIP implementation efforts.

"Idaho is moving forward with the development of regional interoperable communications governance structures that will be driven by our local response community. The SCIP [Implementation] Workshop recently conducted in Idaho by OEC delivered the message that governance is the "umbrella" under which all decisions about interoperable communications will be made in a collaborative manner. The workshop gave us direction and made sense of the SCIP implementation process."
