

## Considerations for the Walker and Carson Basin

---

- **Operational Coordination**

- What is the plan to release from the reservoirs?
- How will the inflow rate be monitored?
- How will the reservoir/river monitoring and reporting be communicated to local agencies, state agencies, and the public?
- Re-flood potential?
- Route/debris clearance removals
- What is the expected impact on infrastructure and residents for the various expected releases and the maximum release?
- What additional resources are needed?
- How are additional resources requested from other counties and from the state?
- If additional resources are needed, how are out of state agencies incorporated into the response effort?
- How is media and reporting requests handled during incidents?
- What is the COOP plan?
- What point is the maximum release decision made for the Bridgeport Reservoir?
- How are detours coordinated through state and local agencies? How is this coordinated and communicated to communities?
- How will the community and response teams be notified of activation?
- When do we determine when to respond compared to the prediction of flood? Triggers?
- How will evacuation efforts be coordinated?

- **Natural Resources**

- What are the agriculture concerns?
- Major events (i.e. Night in the Country July 27-29)

- **Public Information Warning**

- When will residents be notified of road closures?
- Alternate routes identify and publicize? Town hall meeting?
- What triggers have been identified by potential flooding of farmlands?
- Have residents been notified of the potential flooding?
- How will messaging be conducted to the community?
- When is it time to sandbag houses and other critical infrastructure?
- When and what is appropriate to message?
- If traffic routes are cut and there is an increase in traffic, accidents, and medical needs, how will this be messaged?

- **Critical Transportation**

- Are there other roads that can be impacted?
- Who is the evacuation authority?
- Precautionary evacuation routes?
- Any homes identified for evacuation?

- Identified evacuation routes? Trigger points?
- Transportation support for evacuation?
- **Security Protection, and Law Enforcement**
  - NDOT support for any road closures?
  - Security or Law Enforcement needed for evacuation of properties?
  - What is the plan for prisoner evacuations?
  - What is the plan for looting prevention?
- **Mass Care Services**
  - Impacted populations? (Vulnerable population, access and functional needs)
  - Shelter plans and locations? (out of town)
  - Is sheltering in place a possibility?
  - What is the plan for getting medical assistance, prescriptions, durable medical goods, and the pet sheltering plan (in or out of town)?
- **Infrastructure Systems**
  - What infrastructure are likely to be impacted? (Power and water)
  - How can Critical Infrastructure be protected? (eg. sandbag and removal)
  - Bridges/overpasses compromised?
- **Mass Search and Rescue**
  - Water rescue
- **Fire Management and Suppression**
  - Any potential impacts with road closure, isolations and etc?
- **River Flow Schematic (Canals, ditches, etc.)**
  - Limitation/Capacity
- **Environmental Response/ Health and Safety**
  - Mining and/or HAZMAT issues or concerns?
  - Impacts to well, septic, and sewer systems
  - What is the plan for decon of first responders?
