- 5. REPORT ON THE PASSAGE OF SENATE BILL (SB) 39 AMENDING NEVADA REVISED STATUTE (NRS) 239C (Discussion Only) Christopher Smith, Chief of the Nevada Division of Emergency Management and Homeland Security will update the Commission on the passage of SB 39, which amends NRS 239C to provide committees under the Commission to hold closed meetings.

- 6. **UPDATE ON THE STATUS OF THE SONNet COMMITTEE** (Discussion Only) Chris Magenheimer will provide a report from the SONNet Committee on recent developments with the federal FirstNet Board, and provide an update to the Commission on the territory consultation meeting held between FirstNet and the National Governor's Association on May 29-30, 2013.
- 7. REVIEW AND UPDATE ON THE FEDERAL FISCAL YEAR (FFY) 2013 HOMELAND SECURITY GRANT PROGRAM (HSGP) PROCESS AND ALLOCATIONS (Discussion Only) Chief Christopher Smith, State Administrative Agent (SAA), Nevada Division of Emergency Management, and Chief Fernandez Leary, Urban Area Administrator (UAA). The Commission will hear an update on the FFY 2013 HSGP federal fund allocations to Nevada. The Commission will also hear a report on the process and outcome from the June 13, 2013 Homeland Security Working Group (HSWG) meeting and the subsequent recommendation to the Finance Committee for the FFY 2013 grant allocation to Nevada.

REPORT ON THE JUNE 19, 2013 MEETING OF THE FINANCE COMMITTEE TO EVALUATE AND MAKE RECOMMENDATIONS FOR THE FFY 2013 HOMELAND SECURITY GRANT PROGRAM (HSGP) PROJECTS (Discussion/For Possible Action) Sheriff Doug Gillespie, Chairman, Finance Committee. Chairman Gillespie will provide a briefing on the results of the June 19, 2013 Finance Committee meeting where the budgets and projects for FFY 2013 HSGP as recommended by the HSWG were discussed. This briefing will include recommendations to the Commission for final funding of those projects. The Commission will be asked to review the Finance Committee recommendations and formulate a final recommendation to the Governor regarding the approval of the FFY 2013 Homeland Security Grant Program application.
