- 1. CALL TO ORDER AND ROLL CALL Chair, Governor Brian Sandoval.
- 2. **PUBLIC COMMENT** (Discussion Only) No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.
- **3. APPROVAL OF MINUTES** (Discussion/For Possible Action) Chairman, Governor Sandoval. This agenda item will discuss whether or not to approve the minutes of the December 4, 2013 Nevada Commission on Homeland Security meeting.
- 4. **COMMENTS BY THE CHAIRMAN** (Discussion Only) Chairman, Governor Sandoval.

- 5. REQUEST TO REALLOCATE HOMELAND SECURITY GRANT PROGRAM (HSGP) FUNDS – (Discussion/For Possible Action) – Finance Committee Chairman, Doug Gillespie. Note: This agenda item will brief the Commission on the recommended re-obligations to HSGP projects discussed during the February 27, 2014 meeting of the Finance Committee. The Committee is asking the Commission to recommend their findings on these actions to the Governor for final approval.
 - <u>NCHS-89 Re-Obligation</u>: Nevada Department of Administration, Buildings and Grounds. Sawyer Office Building Force Protection. This request is for funding to provide force protection improvements for the state building in Las Vegas as identified in a site assistance visit to provide heightened security levels while minimizing the vulnerability. Total cost of Phase I is \$73,529.00; Total cost of Phase II is \$65,693.00. The total combined cost of both phases is \$139,222.00.
 - <u>NCHS-93 Re-Obligation</u>: City of Reno. Telecommunicator Emergency Response Taskforce Training. This request will provide the training necessary to have sufficient personnel available to respond to other 9-1-1 centers to maintain their community's lifeline during catastrophic events. The total cost of this request is \$4,500.00.
 - <u>NCHS-107 Re-Obligation</u>: East Fork Fire and Paramedic District. Chemical, Biological, Radiological, Nuclear, and High Yield Explosive (CBRNE) Hazmat-Fit Test Machine. This request is to fund the purchase of a Mask Leak Fit Tester to be used by East Fork Fire Paramedic Districts, Tahoe Douglas Fire Protection District and the Douglas County Sheriff's Office. The total cost of this request is \$11,310.00.
 - <u>NCHS-108 De-Obligation</u>: Clark County Fire Department. Fusion Center. This request is to deobligate funds for Training Liaison Officer (TLO) position. The total amount of this deobligation request is \$120,000.00.
 - <u>NCHS-108 Re-Obligation</u>: Clark County Fire Department. Personal Protective Equipment (PPE) for Southern Nevada Fire Use in Hostile Mass Casualty Incidents (MCIs). This request is to reobligate funding for ballistic vests and helmets for fire personnel to work alongside law enforcement in an active shooter incident. The total cost of this request is \$118,708.00.
 - <u>NCHS-109 Re-Obligation</u>: Inter-Tribal Council of Nevada (ITERC). Tribal Threat, Hazard, Identification, and Risk Assessment (THIRA). This request is for training and workshops for the THIRA project. The total cost of this request is \$11,550.00.
 - <u>NCHS-110 Re-Obligation</u>: Nevada Division of Emergency Management. Statewide Continuity of Operations Plan (COOP). This request is for funding to continue statewide COOP and Continuation of Government (COG) capabilities. The total cost of this request is \$38,032.00.
 - <u>NCHS-111</u>: City of Las Vegas. Southern Nevada Unified Command (SNUC) Incident Command. This project change request is to change from purchasing reference materials, communication equipment, and field incident materials to purchasing an Incident Management Team (IMT) Trailer and Incident Command System (ICS) laminated wall mounts. The total cost of this request is \$5,183.09.

 - Presentation of information for developing the Nevada Commission on Homeland Security Priorities for FFY 2014 HSGP using the results from the SPR. THIRA, and State Homeland Security Strategy.
