

PUBLIC ASSISTANCE COVID-19 PROJECT DEVELOPMENT BULLETIN #25 – 4/28/20

FEMA has recently released their Streamlined Project Application for all FEMA Public Assistance COVID-19 projects. This streamlined application is available on the FEMA Grants Portal under Resources.

The streamlined application will break out projects into the following categories. Depending on which category your project falls in will determine which application schedule you will complete.

A Expedited Funding Estimate	<p>Large projects only</p> <p>To be completed for expedited funding.</p> <p>Applicants may request if they have an immediate need for funding to continue emergency protective measures.</p> <p>If approved, they will be awarded 50% of the FEMA-confirmed project cost based on the initial documents.</p> <p>They will be required to provide all information to support actual incurred costs for the 50% before receiving any additional funding.</p> <p>Not recommended for those that have never received Public Assistance funding and do not have significant experience with federal grant requirements.</p>
B Completed Work Estimate	Large projects that are 100% complete.
C In-progress Work Estimate	Large projects that are 0-99% complete.
D Large Project Eligibility Questions	<p>For large projects only.</p> <p>Part 1 - Must be completed for ALL</p> <p>Part 2 - To be completed if supplies or equipment was purchased</p> <p>Part 3 - To be completed if land or buildings were purchased</p> <p>Part 4 - To be completed if food, water, ice, or other commodities were/will be distributed or purchased</p> <p>Part 5 - To be completed if meals for emergency workers were/will be purchased</p>

	Part 6 - To be completed if supplies, equipment, or other resources were/will be pre- positioned or moved Part 7 and 8 - To be completed if emergency medical care was/will be provided Part 9 - To be completed if sheltering was/will be provided Part 10 - To be completed if a temporary facility is/will be established

F Environmental and Historical Preservation Questions	For large or small projects where the following was reported: Part 1 - Staging of resources at an undeveloped site Part 2 - Storage of human remains or mass mortuary services Part 3 - Medical waste disposal Part 4 - Decontamination systems Part 5 - Establishment of temporary facilities

Additionally, this application will walk you through the process of how to put together your projects. The Nevada Division of Emergency Management (DEM) recommends projects be broken out into the following categories:

Management, control, and reduction of immediate threats to public health and safety:

- Emergency operations center activities
- Training
- Facility disinfection
- Technical assistance on emergency management
- Dissemination of information to the public to provide warning and guidance
- Pre-positioning or movement of supplies, equipment, or other resources
- Purchase and distribution of food, water, or ice
- Purchase and distribution of other commodities
- Security, law enforcement, barricading, and patrolling (cont.)
- Storage of human remains or mass mortuary services

Emergency Medical Care:

- Personal Protective Equipment only

Emergency Medical Care:

- In vitro diagnostic supplies only

Emergency Medical Care:

- Decontamination systems only

Emergency Medical Care:

- Therapeutics only

Medical Services:

- Disease testing
- Treatment
- Diagnosis
- Emergency medical transport
- Medical waste disposal

Sheltering:

Isolation related Temporary Lodging

Sheltering:

Quarantine related Temporary Lodging
