3. **ANNUAL NOMINATION AND SELECTION OF THE FINANCE COMMITTEE CHAIR AND VICE-CHAIR** – (Discussion/For Possible Action) – David Fogerson, SAA. Pursuant to NRS 239C.170 (1), the Committee members will nominate and vote for a member to serve as the Finance Committee Chair and second member to serve as the Finance Committee Vice-Chair.

4. **APPROVAL OF MINUTES** – (Discussion/For Possible Action) – New Chair as selected in Agenda Item #3. The Committee will determine whether to approve the minutes of the September 7, 2022, Committee meeting.

5. **APPROVAL OF PROJECT CHANGE REQUEST (PCR) ABOVE THE \$100,000 THRESHOLD** - (Discussion/For Possible Action) - Jared Franco, Division of Emergency Management/Homeland Security (DEM/HS) and Rachel Skidmore, Las Vegas Metropolitan Police Department (LVMPD). The Committee will determine whether to approve PCR #3 on Federal Fiscal Year (FFY) 2021 Urban Areas Security Initiative (UASI) LVMPD – Multi-Coordinated Tactical Response Grant. LVMPD is requesting a budget augmentation of over \$100,000.00 and requires approval from Nevada Commission on Homeland Security Committee on Finance and Homeland Security Commission.

6. **FEDERAL GRANT REOBLIGATION GUIDELINES** – (Discussion/Possible Action) – David Fogerson, SAA. The Committee on Finance will review and potentially re-adopt the re-obligation process which was originally produced in 2011.
