Items may be pulled or removed from the agenda at any time.

1. **CALL TO ORDER AND ROLL CALL** – Chair, Governor Joe Lombardo
2. **PUBLIC COMMENT**– (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on the agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.

3. **APPROVAL OF MINUTES** – (Discussion/For Possible Action) – Chair, Governor Joe Lombardo. The Commission will discuss and review the minutes of the December 5, 2022, Commission meeting. The Commission will determine whether to approve the meeting minutes.
4. **ANNOUNCEMENT OF VICE CHAIR BY GOVERNOR LOMBARDO** – (Discussion Only) – Governor Joe Lombardo will announce his selection for Vice-Chair of the Commission, who will serve as Chair in his absence.

5. **DISCUSSION ON CYBER SECURITY EFFORTS WITHIN NEVADA** – (Discussion Only) – Commission members will learn about cyber security efforts under way in Nevada.
 - a. **Cyber Security Task Force** – Tim Robb. Mr. Robb will discuss the Cyber Security Task Force role, responsibilities, and vision.
 - b. **Cyber Security Landscape** – Dave Fogerson. Mr. Fogerson will discuss the cyber security landscape within Nevada and will identify agency responsibilities.
 - c. **Office of Cyber Defense and Coordination (OCDC)** – Aakin Patel. Mr. Patel will discuss the roles, responsibilities, and vision for OCDC.
 - d. **Nevada Enterprise Information Technology (EITS): Chief Information Security Officer (CISO)** – Bob Dehnhardt. Mr. Dehnhardt will discuss the roles, responsibilities, and vision of EITS and CISO.
 - e. **Office of the Military, Nevada National Guard Joint Cyber Security Task Force.** – Colonel Daniel Waters. COL Waters will discuss the Guard’s Joint Cyber Security Task Force role, responsibilities, and vision.
 - f. **Cybersecurity and Infrastructure Security Administration (CISA)** – Dr. Richard Hays. Dr. Hays will present a discussion on the roles, responsibilities, and vision for CISA within Nevada.
 - g. **Division of Emergency Management and Homeland Security** – Jon Bakkedahl. Mr. Bakkedahl will discuss the consequence management or reactive posture role, responsibility, and vision using the Policy Group and Nevada Operations Center.
6. **REPORT ON THE STATEWIDE ADOPTION OF THE NATIONAL INCIDENT MANAGEMENT SYSTEM (NIMS)** – (Discussion Only) – David Fogerson, State Administrative Agent (SAA). The Commission will be briefed on the quarterly report on the statewide adoption of, and compliance with, the NIMS, as required by Nevada Revised Statutes (NRS) 239C.310.
7. **REVIEW OF 2022 ANNUAL REPORTS** – (Discussion Only) – David Fogerson, SAA. The 2022 Annual reports from the Nevada Resilience Advisory Committee and the Homeland Security Commission will be presented to the Commission.
8. **REVIEW OF THE FEDERAL FISCAL YEAR (FFY) 2023 STATE HOMELAND SECURITY PROGRAM (SHSP) AND THE URBAN AREAS SECURITY INITIATIVE (UASI) PROGRAM RECOMMENDATIONS** – (Discussion/For Possible Action) – David Fogerson, State Administrative Agency (SAA) and Deputy Chief Billy Samuels, Urban Area Administrator (UAA). The Commission will review and discuss the SHSP and the UASI funding recommendations submitted by the Nevada Resilience Advisory Commission (NRAC), the Urban Area Working Group (UAWG), and the Committee on Finance for the FFY 2023 Homeland Security Grant Program (HSGP). Evaluation of all proposals, including additional recommendations of proposal allocations, may be conducted with the intent to vote on a final recommendation. HSGP project managers may be required to answer questions pertaining to their proposals. A list of the FFY 2023 project submissions will be provided in the meeting materials.
9. **PROJECT CHANGE REQUEST (PCR) ABOVE THE \$100,000 THRESHOLD** – (Discussion/For Possible Action) – Jared Franco, Nevada Division of Emergency Management/Homeland Security (DEM/HS) and Rachel Skidmore, Las Vegas Metropolitan Police Department (LVMPD). The Commission will determine whether to approve PCR #3 on FFY 2021 Urban Areas Security Initiative (UASI) LVMPD – Multi-Coordinated Tactical Response Grant. LVMPD is requesting a budget augmentation of over \$100,000.00 and

requires approval from the Nevada Commission on Homeland Security Committee on Finance and the Homeland Security Commission.

10. **FEDERAL GRANT REOBLIGATION GUIDELINES** – (Discussion/Possible Action) – David Fogerson, SAA. The Commission will review and potentially re-adopt the re-obligation guidelines, which were originally produced in 2011, and recently updated.
11. **GRANT STATUS REPORT FOR FFY’S 2019, 2020, 2021, AND 2022** – (Discussion Only) – Suz Coyote, DEM/HS and Jared Franco, DEM/HS. The Commission will receive quarterly grant reports, which will outline the spending status on Emergency Management Performance Grant (EMPG), Homeland Security Grant Program (HSGP), and Emergency Preparedness Working Group Grant (EPWG). The Commission will also be briefed on the status of current grants, expected grants, and on the late status of reporting of current grants.
12. **DEM/HS FEMA AUDIT RESULTS FOR FFY’S 2022 AND 2023** – (Discussion Only) – Jared Franco, DEM/HS. The Commission will receive a briefing on various audits that DEM/HS has undergone relating to COVID19, Homeland Security Grant Program (HSGP), and Emergency Management Performance Grant (EMPG).
