1. **CALL TO ORDER AND ROLL CALL** – Chair, David Fogerson, State Administrative Agent (SAA) and Vice-Chair, Deputy Chief Billy Samuels, Urban Area Administrator (UAA).
2. **PUBLIC COMMENT**– (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on the agenda as an item upon which action may be taken. 3. **APPROVAL OF MINUTES** – (Discussion/For Possible Action) –Chair, David Fogerson. The Committee will discuss and review the minutes of the April 25, 2023, Committee meeting. The Committee will determine whether to approve the meeting minutes.
4. **STATE HOMELAND SECURITY GRANT PROGRAM (SHGP) PROCESS FOR 2024** – (Discussion Only) – Chair, David Fogerson and Co-Chair Billy Samuels. NRAC members will discuss the process for grant ranking in the Spring of 2024 for SHGP projects. Discussion may include required review of all grant applications, improving definitions for sustained program or sustained cost, new project, and other related items to clarify the process that NRAC uses to make recommendations to the Committee on Finance, Homeland Security Commission, and the Governor via the State Administrative Agent.
5. **SCHOOL SAFETY PLANS** – (Discussion Only) - Megan Hall, Nevada Division of Emergency Management/Homeland Security (DEM/HS). Ms. Hall will update the Committee on the status of School Safety Plans as received by the DEM/HS required by NRS 388.243. The

Committee will hear on how many plans were received and the process for plans to be reviewed.

6. **GRANT STATUS REPORTS** – (Discussion Only) - Jared Franco, DEM/HS. Mr. Franco will provide the Committee with the quarterly grant report which outlines a spending status on open Homeland Security Grant Program (HSGP) grants.
7. **DEM/HS FEMA AUDIT RESULTS FOR THE FEDERAL FISCAL YEAR (FFY) 2022 AND 2023** - (Discussion Only) - Jared Franco, DEM/HS. The Committee will receive a briefing on the various audits that DEM/HS has undergone relating to COVID, HSGP, and Emergency Management Performance Grant (EMPG).
8. **CYBER SECURITY TASK FORCE (CSTF)** – (Discussion Only) – Tim Robb, Governor Liaison, Chair of CSTF. Mr. Robb will update the Committee on the CSTF meeting that took place on June 30, 2023.
9. **AFTER ACTION REPORTS (AAR)** – (Discussion Only) – Rodney Wright, DEM/HS, Training and Exercise Supervisor. Mr. Wright will discuss the after-action reports which have been produced from events, incidents, and exercises with the focus on improvement plan or lesson learned items which the state is working on.
10. **WICKED PROBLEMS DISCUSSION** – (Discussion Only) – Chair David Fogerson and Carolyn Levering, City of Las Vegas Emergency Manager. Ms. Levering and Mr. Fogerson will discuss the Vanguard program they were involved in, focusing on the wicked problems within emergency management, including but not limited to the funding of emergency management, successorship of positions, and improving Nevada’s resilience. Chair Fogerson and Ms. Levering will seek ideas from NRAC on how wicked problems can be addressed in Nevada.
