- 1. CALL TO ORDER AND ROLL CALL Chairman, Governor Brian Sandoval.
- 2. **PUBLIC COMMENT** (Discussion Only) No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.
- **3.** APPROVAL OF MINUTES (Discussion/For Possible Action) Chairman, Governor Sandoval. This agenda item will discuss whether or not to approve the minutes of the February 28, 2018, Commission meeting.
- 4. **COMMENTS BY THE CHAIRMAN** (Discussion Only) Chairman, Governor Sandoval.
- 5. UPDATE ON THE DIVISION OF EMERGENCY MANAGEMENT'S EFFORTS PERTAINING TO SCHOOL EMERGENCY RESPONSE PLANS (Discussion Only) Chief Caleb Cage, Division of Emergency Management (DEM). Chief Cage will brief the Commission on the state response in receiving and maintaining school safety plans.
- 6. BRIEFING ON GRANT FUNDING AVAILABILITY TO ADDRESS SCHOOL SECURITY – (Discussion Only) – Connie Lucido, Administrator, Nevada Department of Administration, Office of Grant Procurement, Coordination & Management. Ms. Lucido will brief the Commission on grant funding to address school security at the state, local, tribal, school district, and other jurisdictional levels throughout the state.

- 7. BRIEFING ON EXECUTIVE ORDER (EO) 2018-5, STATEWIDE SCHOOL SAFETY TASK FORCE – (Discussion Only) – Superintendent Steve Canavero, Nevada Department of Education. Superintendent Canavero will brief the Commission on the March 19, 2018, Executive Order creating the Statewide School Safety Task Force addressing the application of statewide resources to enhance school safety.
- 8. BRIEFING ON THE SPECIAL LAW ENFORCEMENT SUMMIT ON SCHOOL SAFETY HOSTED BY THE OFFICE OF THE NEVADA ATTORNEY GENERAL ON MARCH 14, 2018 – (Discussion Only) – Office of the Attorney General. The Commission will be briefed on the summit's focus in examining Nevada laws, protocols, and security measures to ensure school safety including how school staff and law enforcement can share information to identify, report, and prevent potential threats to Nevada's schools.
- **9. BRIEFING ON THE SAFEVOICE NEVADA PROGRAM** (Discussion Only) Lieutenant Andrew Rasor, Nevada Department of Public Safety, Investigation Division (NDI) and Director Christy McGill, Nevada Department of Education (DOE), Office of Safe and Respectful Learning Environments. Lieutenant Rasor and Director McGill will brief the Commission on the SafeVoice Nevada program established by the Nevada Department of Education under Senate Bill 212, and in partnership with the Nevada Department of Public Safety, to create an anonymous reporting system used to report threats for the safety and well-being of students.
- 10. NEXT STEPS IN ADDRESSING SCHOOL SAFETY WITHIN NEVADA (Discussion/For Possible Action) Chairman, Governor Sandoval. Governor Sandoval will elicit input from the Commission on future coordination of emergency management, grant funding, the Statewide School Safety Task Force, the Attorney General's school safety law enforcement efforts, and SafeVoice Nevada in order to address school safety in Nevada. Commissioners may be asked to provide input and vote on recommendations regarding next steps that may include continued oversight of these various efforts, additional briefings to the Commission, recommended policies for improving school safety and security, and other statewide coordination efforts.
- 11. **PUBLIC COMMENT** (Discussion Only) No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.
