1. **CALL TO ORDER AND ROLL CALL** –Chair, Tim Robb.
2. **PUBLIC COMMENT**– (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on the agenda as an item upon which action may be taken. 4. **NEVADA CYBERSECURITY GRANT** – (Discussion Only) – Sharon Luce and Amanda Jackson, Nevada Division of Emergency Management/Homeland Security (DEM/HS). Ms. Luce and Ms. Jackson will discuss with the CSTF the next steps to move forward in the cybersecurity grant process.

5. **CAPABILITIES ASSEMENT** – (Discussion/For Possible Action) – Chair, Tim Robb. The CSTF will review the current draft of the state and local cybersecurity grant program’s Capabilities Assessment and will determine whether to approve or alter it.
6. **CYBERSECURITY PLAN REVIEW** – (Discussion Only) – Chair Tim Robb. The CSTF will review the second edition of the Nevada Cybersecurity Plan as required under the DHS cybersecurity grant. Modifications were suggested by DHS on the document. The CSTF will discuss the plan before it is brought back at a future meeting for adoption.
7. **DISCUSSION ON FUTURE AGENDA ITEMS TO BE CONSIDERED BY THE CYBERSECURITY TASKFORCE** – (Discussion Only) – Chair, Tim Robb. The CSTF members can discuss future items to be considered as this task force matures into addressing the cybersecurity efforts in Nevada’s private businesses, non-governmental entities, local government, and state government agencies.
