6. **INTEROPERABILITY CHANNELS** – (Discussion Only) – Richard Burger, Department of Public Safety (DPS). Mr. Burger will lead a discussion on use of the National Interoperability Field Operations Guide (NIFOG) and Nevada Tactical Interoperability Field Operations Guide (NEVIFOG) radio frequencies to address the utilization of radios for

Search and Rescue purposes. The Board may vote on whether to recommend the addition.
