Items may be pulled or removed from the agenda at any time.

1. **CALL TO ORDER AND ROLL CALL** – Chair, Governor Joe Lombardo
2. **PUBLIC COMMENT**– (Discussion Only) – The first public comment is limited to comments on items on the agenda. No action may be taken upon a matter raised under public comment period unless the matter itself has been specifically included on an agenda as an action item. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.

3. **APPROVAL OF MINUTES** – (Discussion/For Possible Action) – Chair, Governor Joe Lombardo. The Commission will discuss and review the minutes of the February 27, 2024, Commission meeting. The Commission will determine whether to approve the meeting minutes.
4. **RECOGNITION OF NEW HOMELAND SECURITY ADVISOR** – (Information Only) – Chair, Governor Joe Lombardo. The Commission will hear from the Chair on his designation of Tim Robb as his Homeland Security Advisor.
5. **REVIEW OF THE FEDERAL FISCAL YEAR (FFY) 2024 STATE HOMELAND SECURITY PROGRAM (SHSP) AND THE URBAN AREAS SECURITY INITIATIVE (UASI) PROGRAM RECOMMENDATIONS** – (Discussion/For Possible Action) – David Fogerson, State Administrative Agency (SAA) and Deputy Chief Billy Samuels, Urban Area Administrator

(UAA). The Commission will review and discuss the SHSP and the UASI funding recommendations submitted by the Nevada Resilience Advisory Commission (NRAC), the Urban Area Working Group (UAWG), and the Committee on Finance for the FFY 2024 Homeland Security Grant Program (HSGP). Evaluation of all proposals, including additional recommendations of proposal allocations, may be conducted with the intent to vote on a final recommendation. HSGP project managers may be required to answer questions pertaining to their proposals. A list of the FFY 2024 project submissions will be provided in the meeting materials.

6. **DISCUSS THE AFTER-ACTION REPORT (AAR) OF FORMULA ONE** – (Discussion Only) – Billy Samuels, Clark County Fire Department/Emergency Management, Dori Koren, Las Vegas Metropolitan Police Department, and David Fogerson, Nevada Division of Emergency Management. The Commission will hear of the 2023 Formula One event and changes for 2024 event.
7. **REPORT ON THE STATEWIDE ADOPTION OF THE NATIONAL INCIDENT MANAGEMENT SYSTEM (NIMS)** – (Discussion Only) – David Fogerson, State Administrative Agent. The Commission will be briefed on the quarterly report on the statewide adoption of, and compliance with, the NIMS, as required by Nevada Revised Statutes (NRS) 239C.310.
