- 1. CALL TO ORDER AND ROLL CALL/ESTABLISHMENT OF QUORUM** – Chair, Chief Caleb Cage.
- 2. PUBLIC COMMENT**– (Discussion Only) – No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action may be taken. Public comments may be limited to 3 minutes per person at the discretion of the Chair. Comments will not be restricted based on viewpoint.
- 3. APPROVAL OF MINUTES** – (Discussion/For Possible Action) – Chair, Chief Caleb Cage. This agenda item will review and decide whether or not to approve the minutes from the May 29, 2018, EMCC meeting.
- 4. PRESENTATION ON THE AMERICAN RED CROSS MASS CARE STRATEGY: AMERICAN RED CROSS READINESS INITIATIVE** – (Discussion Only) – JaLae Thompson, American Red Cross. Ms. Thompson will provide a presentation on a Mass Care Readiness Initiative. This initiative is intended to increase the capacity and capability needed to reliably accomplish the mass care priorities of sheltering, feeding, distribution of emergency supplies, and reunification.
- 5. PRESENTATION ON THE DEVELOPMENT OF A 2019 COMPLEX COORDINATED TERRORIST ATTACK (CCTA) MULTI-JURISDICTIONAL FULL SCALE EXERCISE (FSE)** – (Discussion Only) – Bud Marshall, Division of Emergency Management. The EMCC will

hear details on the development of a multi-jurisdictional CCTA FSE scheduled for November 2019. The three-day statewide FSE will focus on intelligence and information sharing between fusion centers, law enforcement, and emergency management agencies, translation of information into actionable response, interdiction activities, response, and recovery efforts stemming from the proposed FSE events that will occur in southern and northern Nevada. The EMCC will be briefed on the recruitment of non-participating jurisdictions for involvement as exercise controllers and evaluators.

6. **RESILIENCE STRATEGY UPDATE** – (Discussion Only) – Chair, Chief Caleb Cage. Chief Cage will provide an update on the current status of the state resilience strategy following the approval of the strategy by the Nevada Commission on Homeland Security.
