

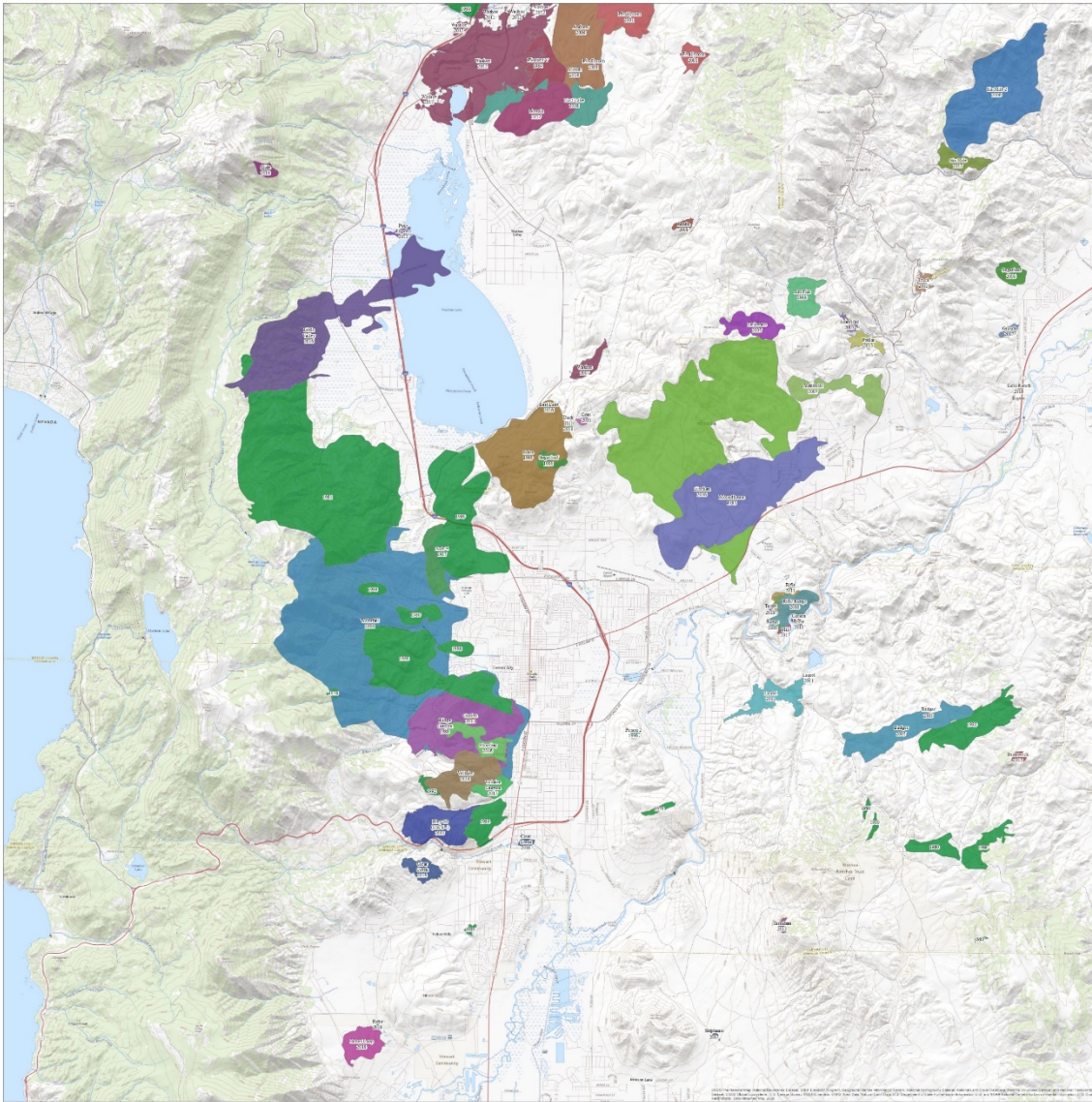

Fire History



↳ Major Wildland Fires in Carson City

- ☞ Waterfall Fire, July 2004, 8,764 acres
- ☞ Linehan Fire, June 2006, 5,863 acres
- ☞ Kings Canyon Fire, Aug. 1988, 1,798 acres

↳ 2015 – 2020

- ☞ 145 Wildfire incidents, 1,176 acres burned

↳ 2000 – 2014

- ☞ 27 major wildfire incidents, 19,271 acres burned

Losses to the Community After a Wildfire

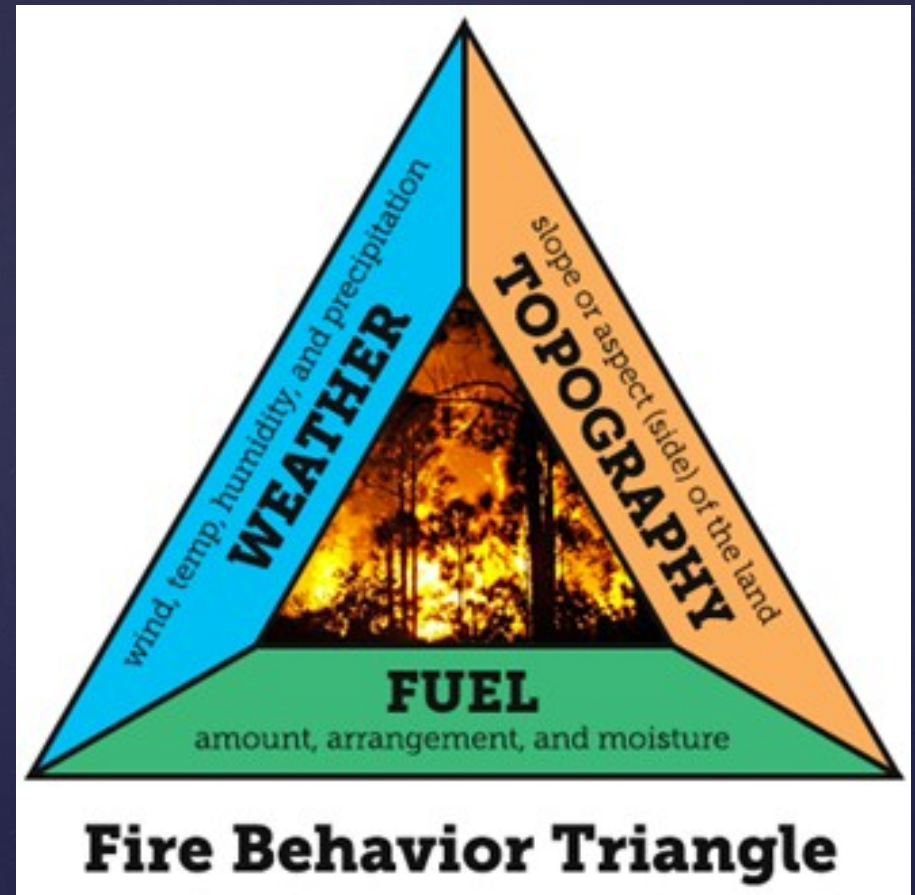
- People Displaced
- Property Damaged
 - Rebuilding process can take years
- Loss of Water Quality
 - Effects local wells and surface runoff
 - Increases erosion, possible landslides
- Recreation opportunities are lost in the area
- Economic impacts
 - Decreased property values
- Environmental Damage
 - Forests transition back to grasslands

What factors influence Wildland Fire behavior

WEATHER – Carson has hot and dry conditions lasting from May through August leaving native vegetation with low fuel moisture content

TOPOGRAPHY – How steep the landscape is, and which direction it is facing

FUEL – The amount, arrangement and moisture content of the fuel. This is the only factor we can manipulate.



What is being done to reduce the threat of Wildfire?



- **“You Call, We Haul”**
 - Trailer and Dumpster program to give homeowners an effective and efficient way to dispose of green waste generated by completing Defensible Space project.
- **Capital City Handcrew**
 - A crew of wildland firefighters that creates landscape scale fuel breaks around at risk communities in the WUI areas.
- **New Owner Program**
 - Fire Dept personnel visit each property that changes ownership in the designated WUI.

“You Call, We Haul”

- 4 – 6 cubic yard dump trailers
- 4 – 20 cubic yard dumpsters
- Program started in 2006 in response to the WaterFire in 2004
- Collected 400 tons of hazardous material in 2020
- Collected 4,500 tons since 2006
= 60 - 737 airliners
- Available to all properties in the designated Wildland Urban Interface



Capital City Hand Crew



- 15-17 person Handcrew
- Made up of full time and seasonal employees
- Create landscape scale fuel breaks around “at-risk” communities
- Trained wildland fire suppression resource
- Treated 250+ acres since 2017
- Hand thinning and prescribed fire operations





New Owner Program

- Visit all new owners within the WUI within 60 days
- Walk their property and discuss potential hazards
- Discuss the importance of Defensible Space
- Advise the new owners of the programs available to them
- Creates a relationship with our residents
