5. **PRESENTATION ON EMERGENCY MANAGEMENT ASSISTANCE COMPACT (EMAC) AND INCIDENT MANAGEMENT ASSIST TEAM (IMAT)** – (Discussion Only) – Rodney Wright, DEM/HS EMAC Coordinator. Mr. Wright will report on the EMAC deployments for 2024, and status on the IMAT Handbook and Operating Guide.
