# Humboldt-Toiyabe National Forest USDA FOREST SERVICE INTERMOUNTAIN REGION, R4

The Humboldt-Toiyabe National Forest is currently advertising for temporary (NTE 1039hrs) Dispatch, Fire Engine, Wildland Fire Module, Helitack, and Hotshot positions. Openings may be available at the GS-03, GS-04, and GS-05 grade levels, with temporary duty/work locations possibly located in:

Nevada (Austin / Carson City / Elko / Ely / Las Vegas / Winnemucca) and in California
(Bridgeport / Topaz) depending on staffing needs and budgets. These are temporary wildland fire positions, with a 5 to 6 month tour of duty. Our earliest anticipated start date is late April to mid-May and we expect to operate until mid-October to late October.

- 5. The Forest is anticipating receiving a list of applicants as early as **December 2024**.

## **How to Apply**

Through the announcement (when available) you may be instructed to electronically attach additional information (e.g.; resume, DD-214, SF-50, training documentation/certificates, college transcripts, etc.) The applicant must select the desired "Duty Location City" in order to be considered.

# <u>Pre-Employment Drug Screening required prior to receiving position Confirmation</u> Letter

WORK CAPACITY TEST (WCT) for Wildland Firefighters: These positions participate in wildland firefighting activities. Based on the type of work performed, PASSING the Work Capacity Test at the arduous level is a "condition of employment." The arduous fitness (Pack) test consists of a three (3) mile hike, within forty-five (45) minutes, while carrying a forty-five (45) pound pack. You are strongly encouraged to consult with your physician and begin training immediately if you are applying for these positions.
