CONDITIONS

CURRENT SITUATION: Per the NWS Reno March Water Outlook, Sierra Nevada SNOTEL sites are mostly 150-250% above median peak snowpack. Spring and early summer weather will play a major role in either mitigating or exacerbating snowmelt flood potential. Per the NWS Elko 2023 Spring Flood Potential for Northern Nevada Rivers and Creeks, released in March, the flood potential has probability to reach or exceed flood stages. Snow measurements this year are above normal for northeastern and central Nevada. Precipitation is also above normal for the water year.
