INCIDENT NAME: Spring Thaw 2023 LOCATION: Nevada (Region 2 and 3) TIME OF INCIDENT: 12:00 AM on 8MAR23

INCIDENT DESCRIPTION: The Nevada Operations Center (NVOC) is partially activated per the Division of Emergency Management (DEM) Spring Thaw Plan. The purpose of this

activation is to increase our efforts for monitoring,

preparedness, and supporting any jurisdictions in responding

to flooding impacts.

CONDITIONS

CURRENT SITUATION (as of 1200 PM on 20JUN23): Per the NWS Reno, cool temperatures continue today with less snowmelt as a result. Flood warnings are still in effect with flood stages at minor to moderate. There are enhanced flows in Eastern Sierra streams with flooding on the Walker River. Humboldt River flows are lowering. Next week temperatures return to near and above normal ranges with a heat wave anticipated for early July. Minor flooding continues along the Humboldt River near Imlay and at Comus. The Walker River near Wabuska continues to be at moderate flood stage at 11.97 feet, about one foot under major flood stage. The Walker River near Mason – Snyder Lane is at 11.09 feet, just under major flooding stage. The Walker River below Weber Reservoir near Schurz is at moderate flood stage at 18.93 feet, just under major flooding stage.


