SBA Offers Disaster Assistance to Nevada Businesses and Residents Affected by the Severe Winter Storms, Flooding and Mudslides

SACRAMENTO, Calif. – Low-interest federal disaster loans are available to Nevada businesses and residents affected by the severe winter storms, flooding and mudslides that occurred Feb. 5-22, 2017, U.S. Small Business Administration (SBA) Administrator Linda McMahon announced today. SBA acted under its own authority to declare a disaster following the May 22 denial of the state’s request for a major disaster declaration for individual assistance.

The disaster declaration makes SBA assistance available in Elko, Eureka, Humboldt, Lander and White Pine counties in Nevada; Cassia, Owyhee and Twin Falls counties in Idaho; and Box Elder and Toole counties in Utah.

“SBA is strongly committed to providing Nevada with the most effective and customer-focused response possible, and we will be there to provide access to federal disaster loans to help finance recovery for businesses and residents affected by the disaster,” said McMahon. “Getting our businesses and communities up and running after a disaster is our highest priority at SBA.”

“Low-interest federal disaster loans are available to businesses of all sizes, most private nonprofit organizations, homeowners and renters whose property was damaged or destroyed by this disaster,” said SBA’s acting Nevada District Director Ben Raju. “Beginning Wednesday, May 31, SBA representatives will be on hand at the following Disaster Loan Outreach Center to answer questions about SBA’s disaster loan program, explain the application process and help each individual complete their application,” Raju continued. The center will be open on the days and times indicated below. No appointment is necessary.

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to businesses and homeowners to help with the cost of improvements to protect, prevent or minimize the same type of disaster damage from occurring in the future.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is available regardless of whether the business suffered any property damage.

Disaster loans up to \$200,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$40,000 to repair or replace damaged or destroyed personal property.

Interest rates can be as low as 3.15 percent for businesses, 2.5 percent for private nonprofit organizations and 1.875 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

The filing deadline to return applications for property damage is July 24, 2017. The deadline to return economic injury applications is Feb. 26, 2018.
