CONDITIONS

CURRENT SITATION (as of 11:00 AM on 14MAR23)

Per the National Weather Service (NWS) Reno, the Atmospheric River will move through Nevada quickly Tuesday and Wednesday. Heavy, wet snow is forecast for the Sierra above 7,500 – 8,000 feet with periods of rain and flooding concerns below 7,000 feet. Wind gusts above 60 miles per hour are expected and more widespread than originally forecasted. Anticipate travel disruptions from flooding, snow load and avalanche issues. Areas along Carson Valley, Smith Valley, and the Carson River could see more serious impacts due to already high flows. **Eureka County flooding has led to the evacuation warning and sheltering of up to 200 individuals.**
